MOTION FOR APPROVAL OF

HUGHES HUBBARD & REED LLP'S INTERIM PAY APPLICATION NO. 1 AND INCORPORATED MEMORANDUM OF LAW

COME NOW Co-Executors DARREN K. INDYKE and RICHARD D. KAHN (collectively, the "Executors") of the Estate of Jeffrey E. Epstein (the "Estate"), by and through Kellerhals Ferguson Kroblin PLLC, and hereby move this Honorable Court for an order approving Hughes Hubbard & Reed LLP's invoices for payment for legal professional services rendered from August 22, 2019 through October 31, 2019.

I. BACKGROUND

After Decedent Jeffrey E. Epstein's death, Co-Executor Darren K. Indyke retained the law firm of Hughes Hubbard & Reed LLP ("HHR") to represent the Estate regarding (a) potential federal and state civil forfeiture actions, (b) other New York and Florida Estate matters, (c) Estate representation in Paris, France, and (d) establishment of a proposed voluntary claims resolution program (the "Epstein Victims' Compensation Program") for the purpose of resolving multiple sexual abuse claims against Mr. Epstein. *See* Affidavit of Marc A. Weinstein attached hereto as **EXHIBIT A**. The legal expenses for representing the Estate from August 22, 2019 to October 31, 2019 are in the amount of Three Hundred Seventy Thousand Eight Hundred Sixty-Three Dollars and Fifty-Six Cents (\$370,863.56), consisting of attorneys' fees in the amount of Three Hundred Fifty-Three Thousand Five Hundred Fourteen Dollars and Zero Cents (\$353,514.00), fiduciary

accountant fees in the amount of One Thousand Eight Hundred Seventy-Two Dollars and Zero Cents (\$1,872.00), paralegal fees in the amount of Four Hundred Forty-Two Dollars and Zero Cents (\$442.00), law clerk fees in the amount of Ten Thousand One Hundred Twenty Dollars and Zero Cents (\$10,120.00), and costs in the amount of Four Thousand Nine Hundred Fifteen Dollars and Fifty-Six Cents (\$4,915.56).

II. VIRGIN ISLANDS LAW RECOGNIZES ATTORNEYS' FEES AS A RECOVERABLE EXPENSE

"An executor or administrator shall be allowed . . . all necessary expenses incurred in the care, management, and settlement of the estate, including reasonable attorney's fees in any necessary litigation or matter requiring legal advice or counsel." V.I. Code Ann. tit. 15, § 568. In the Virgin Islands, "attorneys' fees are one of many expenses of an administrator or executor." *In Matter of Aubain*, No. ST-06-PB-31, 2011 WL 13055253, at *1 (V.I. Super. May 18, 2011). The administrator or executor must demonstrate to the Court that the attorneys' fees generated in administering the Estate were not only incurred in "necessary litigation or matter[s] requiring legal advice or counsel" but were also "reasonable" before they will be allowed in settlement of the account. *In the Matter of Estate of Smith*, Probate No. ST-02-PB-52, 2011 WL 13055153, at *1 (V.I. Super. Ct. Sept 7, 2011).

"The Virgin Islands law treats attorney's fees like any other expense of administration in that they are an expense of the administrator or executor." In Matter of Aubain, 2011 WL 13055253, at *1. Importantly, "[i]t is the duty of the personal representative to pay all the claims against the estate and the expenses of administration of the estate. . . ." In the Matter of the Estate of Bonifacio Latalladi, Deceased, 23 V.I. 353, 356 (Terr. Ct. 1988). Therefore, the administrator or executor is the one who must review the attorney's fee sought to be recovered, find them

reasonable, and move the Court for payment. *Id.* "[U]nder appropriate circumstances and with Court approval, an administrator or executor may pay reasonable attorney's fees from the estate's assets." *In the Matter of Estate of Smith*, 2011 WL 13055153, at *1.

In support of the instant Motion are the Executors' respective affidavits, stating that HHR's legal professional services fees were incurred in the necessary defense and protection of the Estate. The Executors carefully reviewed the legal invoices and deem the invoices reasonable given HHR's significant experience, strong reputation, and ability to competently represent the Estate with potential stateside civil forfeiture matters, other stateside Estate matters, representation of the Estate in France, and establishment of the Epstein Victim Compensation Program. The Executors further affirm that the time expended was reasonable and necessary; and that the rates are charged at HHR's standard rate and are well within the range of rates that are customary for such legal services. *See* Affidavits of Darren K. Indyke and Richard D. Kahn attached hereto as **EXHIBITS B & C**.

III. GIVEN THE ESTATE'S SIZE AND COMPLEXITY, REPRESENTATION WAS NECESSARY, AND THE FEES WERE NECESSARILY INCURRED

As fiduciaries, the Executors must preserve, protect and safeguard the Estate's assets and owe a duty of undivided loyalty to the Estate. See, e.g., Matter of Buggs, No. P85/1993, 1998 WL 782025, at *1 (Terr. V.I. Oct. 29, 1998) ("[E]xecutor . . . ha[s] the duty to preserve and protect the Estate for the benefit of all interested parties"). The need for HHR's representation of the Estate arose because of potential civil forfeiture of the Estate's assets (including in Paris), ongoing criminal investigations in the Southern District of New York and Paris related to Mr. Epstein, potential French litigation; French corporate, labor, and employment issues (including potential litigation); the need to identify, safeguard, and appraise property (real and personal) in various

jurisdictions, including New York, Miami, and Paris; the need to manage other non-U.S. Virgin

Islands related Estate matters, and the importance of establishing a voluntary, confidential and

non-adversarial alternative to civil litigation for individuals seeking to pursue claims of sexual

abuse against the Estate. Co-Executor Darren K. Indyke properly exercised his duty to protect the

Estate's interests and assets by retaining HHR, even before the Letters Testamentary were issued.

See generally, In re Timpano, 50 N.Y.S.3d 28 (N.Y. Sur. 2016) (Under the law, a

nominated executor has obligations to secure assets of an estate before formal appointment);

Matter of Estate of Donner, 626 N.E.2d 922 (N.Y. 1993) (Decedent's attorney and personal

financial adviser, as executors of decedent's estate, had duty to preserve assets of estate even

before obtaining letters testamentary; given their relationship decedent.

executors had duty to safeguard assets of estate from moment of death to ensure that they were

protected for persons or entities eventually entitled to receive them.).

Similarly, under French law an executor is to take "the necessary precautionary measures

for the proper execution of the will." Article 1029 of the French Civil Code. As such, he may sell

the furniture if there is insufficient cash to pay the urgent debts of the estate (same article) and

even take legal action to ensure execution of the testator's last wishes (Cass. Civ. 1st, May 15,

2008). It is expressly provided that "the expenses incurred by the executor in the exercise of his

mandate are to be borne by the estate." Article 1034 of the French Civil Code. Accordingly,

provided that the fees are related to execution of the will and are necessary for the execution of the

executor's mandate, no rule of French law therefore prevents their payment by the executor. Co-

Executor Darren K. Indyke's diligent exercise of his duty and the high standard of care in retaining

HHR to represent the Estate exemplifies his understanding of his responsibility as an Executor.

Accordingly, this Court should find that HHR's legal professional services are a necessary expense for the representation, defense, and protection of the Estate.

IV. HHR'S FEES ARE REASONABLE

Title 15, section 568 of the Virgin Islands Code does not set forth criteria for assessing the reasonableness of attorneys' fees. Generally, a request for attorneys' fees expended as part of a civil action is governed by 5 V.I.C. § 541. See, e.g., Matter of Estate of Benjamin, Probate No. ST 95 PB-53, 2019 WL 3219450, at *3 (V.I. Super. 2019) (quoting Thomas v. V.I. Bd. of Land Use Appeals, Super. Ct. No. 202/2018 (STT), — V.I. —, 2018 V.I. LEXIS 78, at *3 (V.I. Super. Ct. Aug. 8, 2018)). Attorney's fees are subject to the reasonableness standard of Virgin Islands Supreme Court Rule 211.1.5, which states:

- (a) A lawyer shall not make an agreement for, charge, or collect an unreasonable fee or an unreasonable amount for expenses. The factors to be considered in determining the reasonableness of a fee include the following:
- (1) the time and labor required, the novelty and difficulty of the questions involved, and the skill requisite to perform the legal service properly;
- (2) the likelihood, if apparent to the client, that the acceptance of the particular employment will preclude other employment by the lawyer;
- (3) the fee customarily charged in the locality for similar legal services;
- (4) the amount involved and the results obtained;
- (5) the time limitations imposed by the client or by the circumstances;
- (6) the nature and length of the professional relationship with the client:
- (7) the experience, reputation, and ability of the lawyer or lawyers performing the services; and
- (8) whether the fee is fixed or contingent.

V.I. S. Ct. R. 211.1.5. In calculating the "lodestar" amount, courts consider the same factors as those identified in Rule 211.1.5. *See Yearwood Enterprises, Inc. v. Antilles Gas Corp.*, No. ST-17-CV-77, 2017 WL 6316625, at *2 (V.I. Super. Dec. 5, 2017), aff'd, 69 V.I. 863 (2018).

"Importantly, nothing in the statute purports to mandate that the Superior Court is precluded from granting the full amount of attorney's fees and costs requested." *Hansen v. Bryan*, No. 2017-0050, 2018 WL 1901581, at *6 (V.I. Apr. 20, 2018).

Reasonable attorneys' fees may include charges for work that was "useful and of a type ordinarily necessary to secure the final result obtained from the litigation." *Pennsylvania v. Delaware Valley Citizens' Council for Clean Air*, 478 U.S. 546, 561 (1986); see also Gulfstream III Associates, Inc. v. Gulfstream Aerospace Corp., 995 F.2d 414, 420 (3d Cir. 1993) (noting that reasonable attorneys' fees may include charges for measures necessary to enforce district court judgments as well as other charges "reasonably expended" to advance the litigation).

Banco Popular de Puerto Rico v. Paradise Motors, Inc., Civil No. 2004–162, 2008 WL 4222085, *1 (D.V.I. 2008). "In determining whether to award attorney fees, the decision is informed by the Court's familiarity with the matter in litigation and the interest of justice." Afros S.p.A. v. Krauss-Maffei Corp., 671 F. Supp. 1402, 1441 (D. Del. 1987), aff'd, 848 F.2d 1244 (Fed. Cir. 1988); see also Herbison v. Schwaner, No. A-1-CA-34997, 2019 WL 1228072, at *4 (N.M. Ct. App. Feb. 4, 2019) ("the court can determine a reasonable fee based on the court's knowledge of the case and the pleading in the file").

Finally, the Virgin Islands Supreme Court has noted that the Superior Court's determination of a motion for award of attorneys' fees must be supported by an explanation in order to allow for meaningful appellate review. *Mahabir v. Heirs of George*, 63 V.I. 651, 668 (V.I. 2015) (quoting *James v. Faust*, 62 V.I. 554, 559 (V.I. 2015)).

Under French law, courts essentially arrive at a similar reasonableness analysis by looking to two principles. The first is the principle of freedom in setting lawyers' fees, under which the client and lawyer have discretion to reach an agreement on fees but the lawyers' fees are to be based on certain criteria. Legal fees (for representation, consultation, assistance, advice, drafting of legal acts under private signature and pleadings) are to be fixed in an agreement with the client

within the framework of a written fee agreement. Art. 10 (1) 1, of French law no. 71-1130 of

December 31, 1971. Lawyer's fees will be based, in particular, on each of the following elements

in accordance with customary practice: the time devoted to the case, the research work, the nature

and difficulty of the case, the importance of the interests involved, the impact of the costs and

expenses of the firm to which he belongs, his reputation, qualifications, seniority, experience and

specialization, the benefits and results obtained for the client through his work, as well as the

service rendered to the client and the client's financial situation.

The second principle in France is that courts will look, in the absence of an agreement on

fees, to several criterial to determine what fees would be reasonable. Art. 10 (4) of Law no. 71-

1130 of December 31, 1971. These criteria are:

• The financial situation of the client: the client's financial situation may be one of the

elements involved in determining fees. However, according to the commentators on the

subject, this criterion is minor nowadays.

• The difficulty of the case: a case presenting particular difficulties will justify a higher

fee. This is essentially a matter of taking into account the "added value" of the lawyer.

• The costs incurred by the lawyer: the costs and charges that can be taken into

consideration include (but not exhaustively) so-called structural charges, linked to the

existence of the business, which are generally stable (rental or acquisition of business

premises, maintenance of premises, office equipment and furniture, secretarial

services, payment of employees and associates, IT tools, etc.), and so-called operational

charges, which vary according to the volume of activity (social security charges, office

supplies, telephone, taxes, etc.).

• The reputation of the lawyer: the judge takes into account the seniority of the lawyer,

the consideration he or she enjoys and the talent he or she displays.

• The diligence on the part of the lawyer: all diligence performed by the lawyer must be

remunerated.

Additionally, the French Supreme Court held that a judge who has to assess the

reasonableness of fees may further take into account the duration of the proceedings and their

outcome for the client. Civ, 1, December 10, 2002, no. 99-12.842.

HHR's attorneys' fees incurred in representing the Estate through October 31, 2019 are

Three Hundred Seventy Thousand Eight Hundred Sixty-Three Dollars and Fifty-Six Cents

(\$370,863.56), consisting of attorneys' fees in the amount of Three Hundred Fifty-Three Thousand

Five Hundred Fourteen Dollars and Zero Cents (\$353,514.00), fiduciary accountant fees in the

amount of One Thousand Eight Hundred Seventy-Two Dollars and Zero Cents (\$1,872.00),

paralegal fees in the amount of Four Hundred Forty-Two Dollars and Zero Cents (\$442.00), law

clerk fees in the amount of Ten Thousand One Hundred Twenty Dollars and Zero Cents

(\$10,120.00), and costs in the amount of Four-Thousand Nine Hundred Fifteen Dollars and Fifty-

Six Cents (\$4,915.56), as set forth in the Affidavit of Marc A. Weinstein attached hereto as

EXHIBIT A. HHR's fees for its professional legal services squarely meet each criterion set forth

for reasonableness.

A. TIME AND LABOR INVOLVED, COMPLEXITY OF LITIGATION AND CLAIMS, HIGH SKILL
REQUIRED, EXTENSIVE EXPERIENCE, REPUTATION AND SUPERIOR ABILITY OF
COUNSEL SUPPORT REASONABLENESS OF FEES

"In determining the 'lodestar,' or initial valuation of an attorney's services," the Court considers "the number of hours spent on the case and the reasonable hourly rate." *Morcher v. Nash*, 32 F. Supp. 2d 239, 243 (D.V.I. 1998) (citing *Jo-Ann's Launder Ctr., Inc.,* 31 V.I. 226, 234, (D.V.I. 1995)). "When calculating the number of hours that are reasonably spent on a task for purposes of making an attorney's fee award, a [] court may look to its own familiarity with a case, its experience with that case, and its experience generally, as well as . . . arguments of the parties. *In re Smith*, 331 B.R. 622, 633 (Bankr. M.D. Pa. 2005); *see also Clarke v. Frank*, 960 F.2d 1146, 1153 (2d Cir. 1992).

HHR has provided competent legal representation. As demonstrated by the accompanying Affirmation of Marc A. Weinstein, HHR expended a total of 383.3 attorney hours, 5.2 hours fiduciary accountant hours, 1.5 paralegal hours, and 44 law clerk hours, on representing the vast Estate at a total labor cost of Three Hundred Sixty-Five Thousand Nine Hundred Forty-Eight Dollars (\$356,948.00)

Given the nature of the civil forfeiture matters, the proposed voluntary claims resolution program and its potential impact on other pending and threatened litigation, the ongoing criminal investigation, the other Estate matters in France, and non-U.S. Virgin Islands matters related to this complex Estate, HHR expended numerous hours reviewing documents, conducting extensive legal research, analysis and strategy, drafting legal briefs and memoranda, and meetings/conference calls with the Executors, counterparties and potential litigation adversaries. The time spent was necessary, and the rates charged are fair, reasonable and were incurred by the

Executors in defending and protecting the Estate for the benefit of all legitimate creditors and claimants and for the Estate's beneficiaries.

Considerable skill is required to represent the Estate, which is in excess of Five Hundred Million Dollars (\$500,000,000.00). HHR is required to have attorneys duly licensed to competently practice law in France, including corporate, labor and employment, tax, estate, criminal litigation, civil litigation, civil asset forfeiture, and practice and procedure before civil and commercial French courts. HHR is also required to have a strong understanding of civil asset forfeiture proceedings and criminal investigations in the United States, the ability to skillfully manage non-U.S. Virgin Islands Estate related matters, and knowledge regarding the establishment of a voluntary claims resolution program along the lines contemplated by the Executors in the proposed Epstein Victims' Compensation Program.

Regarding HHR's experience, reputation, and ability, HHR is a highly coveted, top-tier international law firm. See Hughes Hubbard & Reed LLP, www.hugheshubbard.com. Id. Parker F. Taylor, a partner of HHR, focuses his practice primarily on tax law, and trusts and estates. **EXHIBIT F.** Attorney Taylor has extensive experience in estate administration and controversies, and regularly counsels high-net-worth individuals and families on estate matters. Attorney Taylor has extensive experience in evaluating complex federal and state gift and estate tax issues. Additionally, Attorney Taylor regularly prepares federal and state estate tax returns and federal gift tax returns as well as defends audited gift and estate tax returns. Given the estimated value of the estate and the multi-jurisdictional assets of the estate, it is anticipated that complex federal transfer tax issues will need to be evaluated and addressed by Attorney Taylor. Id. Because the Estate owns property in multiple jurisdictions, including Florida and New York, matters which affect the USVI administration also could impact administrations in mainland jurisdictions and Paris, France. Attorney Taylor's knowledge of Florida and New York probate laws is paramount to evaluating legal issues which may arise in those jurisdictions.

Fara Tabatabai, also a partner of HHR, is an experienced litigator and has served as trial counsel in numerous high-stakes domestic and international disputes. **EXHIBIT G.** In 2019, the *New York Journal* selected Attorney Tabatabai as one of the New York legal profession's "Rising Stars." *Id. Marie-Agnès Nicolas, counsel of HHR, is a member of HHR's Litigation Department, is proficient in French, and works from HHR's Paris, France office. **EXHIBIT I.** Attorney Nicolas has a decade of French criminal and civil litigation experience and has developed a strong understanding and extensive experience in advising clients on a variety of matters, including particularly French criminal investigations and criminal procedure. *Id.* Christian Belloin, senior counsel of HHR, has forty (40) years of extensive corporate experience and is highly competent in corporate commercial law, employment and unfair competition law, and real estate law (including regarding corporate vehicles used to hold real estate assets). **EXHIBIT J.** Attorney Belloin is proficient in French, works from HHR's Paris, France office, and has been recognized in *Best Lawyers in France*. *Id.* Ludmilla Balandine, an associate of HHR, in its Paris, France office, with nearly two decades of French civil litigation experience and experience representing clients in criminal matters. **EXHIBIT K.** Attorney Balandine's experience also includes

arbitration, banking and finance, corporate and contracts litigation. Id. Nadine Voisin, senior

counsel of HR, in its Paris, France office, is a twenty-seven (27) year veteran attorney with

extensive labor and employment law experience in France, including related to compliance with

French registration and reporting requirements for employers. **EXHIBIT L.** Attorney Voisin has

been recognized by Best Lawyers in France, Décideurs Stratégie Finance Droit, and Décideurs

Leadership & Management Capital Humain. Id. Isabelle Benisty, an associate of HHR, in HHR's

Paris, France office, has thirty-three (33) years of considerable litigation experience and in

advising clients on important legal issues. EXHIBIT M. Attorney Benisty has experience

regarding employee-employer litigation (or potential litigation). Id.

Justin S. Cohen, an associate of HHR, has experience working on tax, asset management,

and financial matters. EXHIBIT N. John M. Kilgard, a litigation associate of HHR, has

experience in federal court practice and procedure, and is proficient in French. EXHIBIT O.

Vanessa Woods is an associate of HHR, and her practice focuses on estate planning and

administration and administering complex trusts. **EXHIBIT P.** Each of these attorneys' extensive

legal experience is more particularly detailed in their biographical profiles, attached hereto.

The complexity of this matter requires lawyers with HHR's experience and expertise. This

legal representation concerns a high-profile Estate that is worth over half a billion dollars and that

faces pending or threatened civil proceedings and asset forfeiture proceedings in the United States

and France, as well as pending criminal investigations in various jurisdictions. Media coverage of

the Estate and certain, high-profile public and private figures is unrelenting. The Estate consists

of varied assets, real and personal across the United States, France and the U.S. Virgin Islands.

Adequate defense and protection of the Estate, and the management of non-U.S. Virgin Islands-

related Estate administration issues require significant experience, effort, professionalism and attorney time. Accordingly, the fees proposed to the Court are reasonable under the circumstances.

B. Nature and Length of Professional Relationship with Decedent and Time Limitations

HHR provided comprehensive legal services since shortly after Mr. Epstein's death. HHR immediately defended the Estate at the onset of potential civil asset forfeiture claims and the France litigation, and responded on behalf of the Estate to inquiries in the criminal investigation in the Southern District of New York. The time limitations imposed by these circumstances weighs heavily in favor of finding that the attorneys' fees and costs incurred are reasonable. HHR, with offices in, *inter alia*, New York, Miami, Florida and Paris, was one of a few select firms that could adequately and competently provide a broad array of required legal services in relevant jurisdictions, and that possessed the ability to quickly and effectively represent the Estate.

C. ATTORNEYS' RATES ARE REPRESENTATIVE OF CUSTOMARY RATES IN NEW YORK, = AND FRANCE FOR SIMILAR LEGAL SERVICES

To determine a reasonable hourly rate, the court considers "the reasonable market rate in light of the complexity of the services performed." *Anthony On Behalf of Lewis v. Abbott*, No. 1999-78, 2012 WL 2752154, at *2 (D.V.I. July 9, 2012). "To ascertain that community, [] courts 'are free to look to a national market, an area of specialization market, or any other market they believe appropriate to fairly compensate particular attorneys in individual cases." *Ford v. Fed.-Mogul Corp.*, No. 2:09-cv-14448, 2015 U.S. Dist. LEXIS 3399, at *2-3 (E.D. Mich. Jan. 7, 2015) (quoting *McHugh v. Olympia Entm't, Inc.*, 37 F. App'x 730, 740 (6th Cir. 2002)); *see also, Wayne v. Village of Sebring*, 36 F.3d 517, 533 (6th Cir. 1994) (a court has broad discretion in determining what constitutes a reasonable hourly rate).

In addition to the attorney's own affidavit, satisfactory evidence must be produced supporting that "the requested rates are in line with those prevailing in the community for similar services by lawyers of reasonably comparable skill, experience, and reputation." *Id.* (citing *Blum v. Stenson*, 465 U.S. 886, 896 (1984)); see also, Garvey v. Estate of Moorhead, No. SX-13-CV-210, 2016 WL 9503603, at *4 (V.I. Super. Ct. Aug. 1, 2016).

"The starting point in determining a reasonable hourly rate is the attorneys' usual billing rate." Anthony On Behalf of Lewis, 2012 WL 2752154, at *2. "[T]he actual billing arrangement certainly provides a strong indication of what private parties believe is the reasonable fee to be awarded." Ross v. Congregation B'Nai Abraham Mordechai, 814 N.Y.S.2d 837, 843 (Civ. Ct. 2006) (citing Crescent Publ'g Grp., Inc. v. Playboy Enterprises, Inc., 246 F.3d 142, 151(2d Cir. 2001)); Tri-Star Pictures, Inc. v. Unger, 42 F.Supp.2d 296, 305 (S.D.N.Y. 1999) (a fee agreement is strong indication of reasonableness in determining reasonable fees.); see also Prospect Capital Corp. v. Enmon, No. 08 Civ. 3721(LBS), 2010 WL 2594633, at *4 (S.D.N.Y. June 23, 2010) ("Numerous courts have recognized that 'negotiation . . . of fees by sophisticated clients are solid evidence of their reasonableness in the market."").

For legal services rendered in the representation of the Estate, the attorneys' fees were billed on an hourly basis under a retainer agreement. HHR's standard hourly rates for legal services typically range from Five Hundred Thirty Dollars (\$530.00) to One Thousand Two Hundred Fifty Dollars (\$1,250.00), depending on the attorney's experience and complexity of the matter. These rates are in line with rates customarily charged by equivalent law firms for similar services in New York, New York, the jurisdiction where the civil asset forfeiture matter is being managed, the location of some of the Estate's assets and sites of the proposed Epstein Victim Compensation Program. The rates are also in line with the rates customarily charged by equivalent law firms in

Paris, France (i.e., multinational law firms able to handle complex, cross-disciplinary matters in multiple languages). The Executors' and HHR partner Marc A. Weinstein's respective affidavits attest to the reasonableness of the hourly rates and the fact that those rates were deemed by the Executors, who must be considered sophisticated by virtue of the Executors' legal and financial backgrounds, and HHR to be reasonable. **EXHIBITS A, B, & C.** Moreover, HHR charges other such clients at the same or similar hourly rates.

1. ATTORNEY HOURLY RATES APPROVED IN NEW YORK

Importantly, New York courts have acknowledged that HHR's attorney hourly rates are reasonable even many years ago (legal fees typically increase market-wide on an annual basis). See, e.g., Tessemae's LLC v. Atlantis Capital LLC, 18-CV-4902, 2019 WL 2635956, at *4 (S.D.N.Y. June 27, 2019) (collecting cases supporting reasonableness of "hourly rates ranging from Two Hundred Fifty Dollars (\$250) to One Thousand Sixty Dollars (\$1260) per hour" for partner-level attorneys' work"); Kortright Capital Partners LP v. Investcorp Inv. Advisers Ltd., 392 F. Supp. 3d 382, 407-08 (S.D.N.Y. 2019) (approving hourly rate of One Thousand Two Hundred Dollars (\$1,200.00) for partner-level attorneys' work and an hourly rate of Six Hundred Fifty Dollars (\$650.00) for non-partner level attorneys); Lyda v. Fremantlemedia N. Am., No. 10CV4773-DAB-FM, 2016 WL 4574390, at *3 (S.D.N.Y. July 11, 2016), report and recommendation adopted sub nom. Lvda v. Freemantlemedia N. Am., Inc., No. 10-CV-4773 (DAB), 2016 WL 4581340 (S.D.N.Y. Aug. 31, 2016) (considering higher average rates in New York and finding attorney hourly rate at Six Hundred Seventy-Five Dollars (\$675.00) reasonable); Raniere v. Citigroup Inc., 310 F.R.D. 211, 221-22 (S.D.N.Y. 2015) (counsel requested one-third (1/3) of settlement for attorneys' fee, indicating that the time expended on the case at its typical hourly rates of Six Hundred Fifty Dollars (\$650.00) to Nine Hundred Fifty Dollars (\$950.00) for

partners and Three Hundred Fifty Dollars (\$350.00) to Six Hundred Dollars (\$600.00) for associates would result in roughly the equivalent of the requested one-third (1/3) of the settlement, the Court deemed the request reasonable given the complexity of the case, the jurisdiction, and the reputation and skill of the plaintiff's counsel.); Themis Capital v. Democratic Republic of Congo. No. 09 Civ. 1652(PAE), 2014 WL 4379100, at *7 (S.D.N.Y. Sept. 4, 2014) (observing that "partner billing rates in excess of \$1000 an hour[] are by now not uncommon . . . "); In re Vitamin C Antitrust Litig., No. 05-CV-453, 2013 WL 6858853, at *1 (E.D.N.Y. Dec. 30, 2013) (acknowledging, in addressing a motion for an award of attorneys' fees and costs, that a Six Hundred Fifty Dollar (\$650.00) per hour rate for complex cases is customarily charged); Tyco Healthcare Grp. LP v. Ethicon Endo-Surgery, Inc., No. 3:10CV60 (JBA), 2012 WL 4092515, at *2 (D. Conn. Sept. 17, 2012) (applying New York rates and approving of Eight Hundred Fifty Dollar (\$850.00) per hour for partner); Thai-Lao Lignite (Thailand) Co. v. Gov't of Lao People's Democratic Republic, No. 10 CIV. 05256 KMW DF, 2012 WL 5816878, at *6 (S.D.N.Y. Nov. 14, 2012) (acknowledging that "some courts have awarded fees of more than \$700 [per hour] for highly experienced senior partners."); Union of Orthodox Jewish Congregations of Am. v. Royal Food Distributors Liab. Co., 665 F. Supp. 2d 434, 437 (S.D.N.Y. 2009) (in awarding attorneys' fees and costs, finding that an attorney hourly rate at Seven Hundred Thirty-Five Dollars (\$735.00) reasonable). The District Court of the Virgin Islands has found reasonable and approved hourly rates as high as Eight Hundred Eighty Dollars (\$80.00). See Fee Auditor's Final Report entered in In re Innovative Comm. Co. LLC, Case. 3:07-bk-30012-JFK (D.V.I. Aug. 20, 2010) attached hereto as EXHIBIT Q.

In recent years, courts have recognized that "senior lawyers at top law firms routinely charge well over \$1,000 [an hour]." In re Automotive Parts Antitrust Litigation, Case 2:12-cv-

00103-MOB-MKM, D.E. 578, at 8 (E.D. Mich. July 10, 2017); see also Themis Capital v. Democratic Republic of Congo, No. 09 Civ. 1652(PAE), 2014 WL 4379100, at *7 (S.D.N.Y. Sept. 4, 2014) (observing that "partner billing rates in excess of \$1,000 an hour[] are by now not uncommon"). Additionally, legal professional publications, often cited by courts, recognize rates of up to Two Thousand Dollars (\$2,000.00) per hour as reasonable based on the type of legal services rendered. Sara Randazzo & Jacqueline Palank, Legal Fees Cross New Mark: \$1,500 an Hour, THE WALL St. J., Feb. 16, 2016, available at https://www.wsj.com/articles/legal-feesreach-new-pinnacle-1-500-an-hour-1454960708 (In national markets, "partners routinely charge between \$1,200 and \$1,300 an hour, with top rates at several large law firms exceeding \$1,400." In specialties such as "antitrust and high-stakes litigation and appeals . . . [flor lawyers at the very top of those fields, hourly rates can hit \$1,800 or even \$1,950."); Natalie Rodriguez, Meet the \$2,000 An Hour Attorney: What it Takes to Earn Top Dollar in the Rate-Crunch Era, LAW360, June 11, 2016, https://www.law360.com/in-depth/articles/804421 (attorneys in the most complex fields charge Two Thousand Dollars (\$2,000.00) an hour). Accordingly, HHR's hourly rate range for its attorneys are reasonable in New York.

2. APPROVED ATTORNEY HOURLY RATES IN PARIS, FRANCE

HHR's rates for this matter are U.S. dollar-denominated rates set in New York for HHR attorneys in both the U.S. and France. These U.S. rates for HHR's Paris-based attorneys working on this matter are determined by HHR based on each attorney's relative seniority and experience vis-à-vis the U.S.-based HHR attorneys, and accordingly are reasonable from a U.S. perspective for the same reasons that the above U.S.-based attorney's rates are reasonable. HHR has not had occasion for French courts to evaluate the reasonableness of its U.S. dollar-denominated rates in the Paris market; however, HHR's peer New York firms have largely opened Paris offices as well,

and HHR believes that its U.S. dollar-denominate rates for its attorneys based in Paris are comparable to these peer firms' U.S. dollar-denominated rates.

3. CUSTOMARY AND REASONABLE PARAPROFESSIONAL HOURLY RATES IN NEW YORK, NEW YORK AND PARIS, FRANCE

Similarly, HHR's U.S. dollar-denominated hourly rate for its fiduciary accountant, paralegals and law clerks is reasonable. HHR's paralegals working on the various matters bill at the hourly rate of Two Hundred Ninety-Five Dollars (\$295.00), the fiduciary accountant bills at the hourly rate of Three Hundred Sixty Dollars (\$360.00), and the law clerks bill at the hourly rate of Two Hundred Thirty Dollars (\$230.00). **EXHIBIT A**.

In New York and Paris, this rate range is reasonable for U.S.-based law firms charging U.S.-dollar denominated rates. *See, e.g., Tabatznik v. Turner*, No. 14 CIV. 8135 (JFK), 2016 WL 1267792, at *12 (S.D.N.Y. Mar. 30, 2016) (suggesting that, in the Southern District of New York, paralegal fees range between One Hundred Dollars (\$100.00) and Two Hundred Eighty (\$280.00)); *Genger v. Genger*, No. 14 Civ. 5683 (KBF), 2015 WL 1011718, at *3 (S.D.N.Y. Mar. 9, 2015)(approving Two Hundred Sixty Dollars (\$260.00) to Two Hundred Eighty Dollars (\$280.00) paralegal rates); *Lucky Brand Dungarees, Inc. v. Ally Apparel Resources LLC*, No. 05 Civ. 6757, 2009 WL 466136, at *6 (S.D.N.Y. Feb. 25, 2009) (approving rates of Two Hundred Five Dollars (\$205.00) per hour to Two Hundred Thirty-Five Dollars (\$235.00) per hour for paralegals); *S.E.C. v. Goren*, 272 F. Supp. 2d 202, 208 (E.D.N.Y. 2003)(finding reasonable the hourly rate of Two Hundred Dollars (\$200.00) for accounting services provided by Deloitte and Touche, LLP and FTI Consulting, Inc.); *In re ICS Cybernetics, Inc.*, 97 B.R. 736, 740 (Bankr. N.D.N.Y. 1989)(approving accountant hourly rate of Two Hundred Ten Dollars (\$210.00)).

V. **CONCLUSION**

The Court should approve payment of HHR's invoices in the amount of Three Hundred Seventy Thousand Six Hundred Eighteen Dollars and Fifty-Six Cents (\$370,863.56), consisting of attorneys' fees in the amount of Three Hundred Fifty-Three Thousand Five Hundred Fourteen Dollars and Zero Cents (\$353,514.00), fiduciary accountant fees in the amount of One Thousand Eight Hundred Seventy-Two Dollars and Zero Cents (\$1,872.00), paralegal fees in the amount of Four Hundred Forty-Two Dollars and Zero Cents (\$442.00), law clerk fees in the amount of Ten Thousand One Hundred Twenty Dollars and Zero Cents (\$10,120.00), and costs in the amount of Four Thousand Nine Hundred Fifteen Dollars and Fifty-Six Cents (\$4,915.56). The litigation expenses incurred in representing, defending and protecting the Estate were necessary. The attorneys' fees are reasonable considering the size and nature of the Estate, with assets in the United States, the U.S. Virgin Islands, and France, the potential risk posed by the civil asset forfeiture claims (in the United States and France), the ongoing criminal investigation in France, the French labor and employment, corporate, and tax and estate matters, the potential for civil litigation in France, the immediacy in which HHR could provide such representation, the experience, caliber and reputation of the firm, customary hourly rates in New York and Paris, France for representing high-profile, complicated Estates, and the rate agreed upon by Co-Executor Darren K. Indyke. Each of the lodestar elements and the V.I. Supreme Court Rule 211.1.5 have been met.

WHEREFORE, it is respectfully requested that this Honorable Court grant this Motion for Approval of Hughes Hubbard & Reed LLP Interim Pay Application No. 1.


